EXPRESSION OF INTEREST (EOI)

1. Dockeyard & Engineering Works Ltd, Bangladesh Navy, Sonakanda, Bandar, Narayanganj-1413 intends to work with Joint Venture (JV) for construction of **Riverine Patrol Vessel (RPV)** from a reputed design firm/ shipbuilder/ supplier. Short description of the project is as follows:

a. **Project Description.** Construction and delivery of 05 x Riverine Patrol Vessel (RPV)

b. **Quantity.** 05 (Five) in number.

c. **Construction Material.** Internationally recognized shipbuilding quality (Class approved Mild Steel of Marine Grade AH32 or AH-36) steel.

d. **Classification Standard.** DNV/ GL/ Lloyds/ BV.

e. **Design.**

(1) The RPV shall be designed based on proven hull design. Maximum 10% deviation in dimensional parameters may be allowed with CFD analysis. Detail CFD analysis shall be provided while signing the contract with the procuring entity.

(2) The proven design shall mean at least 3 x Proven design ship already built and satisfactorily operated by any/different navy or coast guard or government maritime security agency.

f. **Basic Technical Specification of RPV.**

(1) Length OA	: 35 to 45 meters.
(2) Breadth (max)	: 6 to 8 meter
(3) Maximum Speed	: Not less than 22 knots
(4) Cruising Speed	: Approx 15 knots
(5) Endurance	: Approx. 1500 Nautical Miles

2. **Qualification of Bidder.**

a. The minimum specific experience for construction and delivery of at least 1(one) Contract of Class vessel successfully completed in Govt./Semi govt./ autonomous body with a value of at least Tk. 570 (Five hundred and seventy) Crore or equivalent foreign currency (USD/EURO/GBP/JPY) within last 5 (Five) years.

Or

The minimum specific experience for construction and delivery of at least 2(two) Contracts of Class vessel successfully completed in Govt./Semi govt./ autonomous body with a value of at least Tk. 285 (Two hundred and Eighty-five) Crore or equivalent foreign currency (USD/EURO/GBP/JPY) within last 5 (Five) years.

b. The required average annual turnover shall be greater than Tk 400 (Four hundred) Crore or equivalent foreign currency (USD/EURO/GBP/JPY) over the last 3 (Three) years or best 3 (Three) years in the last 5 (five) years.

c. Import registration certificate.

d. Attested copy of Valid Trade License or equivalent license.
